

The Embassy of the Kingdom of Spain in Turkey presents its compliments to the Ministry of Foreign Affairs of the Republic of Turkey and has the honour to convey the following information:

On June the 30<sup>th</sup> the Council of the European Union adopted Recommendation 9208/20 on the temporary restriction of non-essential travel into the EU and the possible lifting of such restriction.

Subsequently, on July the 3<sup>rd</sup> the Spanish Ministry of Interior published Order INT/595/2020 modifying certain criteria to implement a temporary restriction of non-essential travel from third countries into the EU and Schengen associate countries for public order and public health reasons (document attached to this NV). This Order states the following:

Art 1.1 states denial of entry to all third country nationals with the exceptions mentioned in letters a) to l) of the aforementioned article. Thus, all nationals of an EU Member State and Schengen associated countries are not affected by this ban, independently of the country from which they travel to Spain.

The Embassy of the kingdom of Spain in the Republic of Turkey avails itself of this opportunity to renew to the Ministry of Foreign Affairs of the Republic of Turkey the assurances of its highest consideration.
